

Rockwall Oratorical Club (ROC)

Release of Liability and General Agreement

In consideration of being permitted to participate in Rockwall Oratorical Club (ROC), please list each family member (hereinafter referred to as "Family") _____

Family agrees to the following:

1. Release, waive, discharge, and covenant not to sue either the Rockwall Oratorical Club, the officers, board members or their families or any other participating family in ROC (hereinafter referred to as Releasees) from liability to Family for any loss or damage and any claim or damage on account of injury to the person or property or resulting in death of a Family member while Family is participating in or traveling to/from ROC activities or on the premises of Chisholm Baptist Church, or any other location with ROC activities.
2. Indemnify Releasees from any loss, liability, damage or cost that may incur due to the presence of Family in or on the premises of Chisholm Baptist Church. Family realizes transportation to and from ROC Club activities is the Family responsibility.
3. Assume full responsibility for and risk of bodily injury, death or property damage while in or on the premises of Chisholm Baptist Church during ROC activities.
4. Expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that, if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. In consideration of being permitted to participate in ROC, for Family, and Family heirs, executors, administrators, and assign, releases and forever discharges all Releasees, and their heirs, administrators, and executors of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage resulting or to result from any accident which may occur as a result of participation in ROC or any activities in connection with ROC.
6. States that both Mother and Father of Family has carefully read the above release and knows the contents of the release and signs this release as Family's own free act.
7. Releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered Family during participation during ROC.
8. ROC operates under Biblical guidelines and believes that the Bible commands to make every effort to live at peace and to resolve disputes with each other in private or within a Christian church (see Matthew 18:15-20; 1 Corinthians 6:1-8). Therefore, the parties agree that any claim or dispute arising from or related to this agreement shall be settled by Biblically based mediation accord to ROC By-laws and Code of Conduct. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement or any dispute arising out of any activities or events associate with ROC and expressly waive their right to file a lawsuit in any civil court against one another or against another ROC family for such disputes, except to enforce an arbitration decision.
9. This agreement shall be binding on each member of the Family, their personal representatives, assigns, heirs, and next of kin.
10. This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
